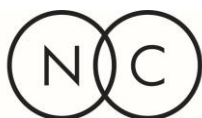

Steel 20% recycled.

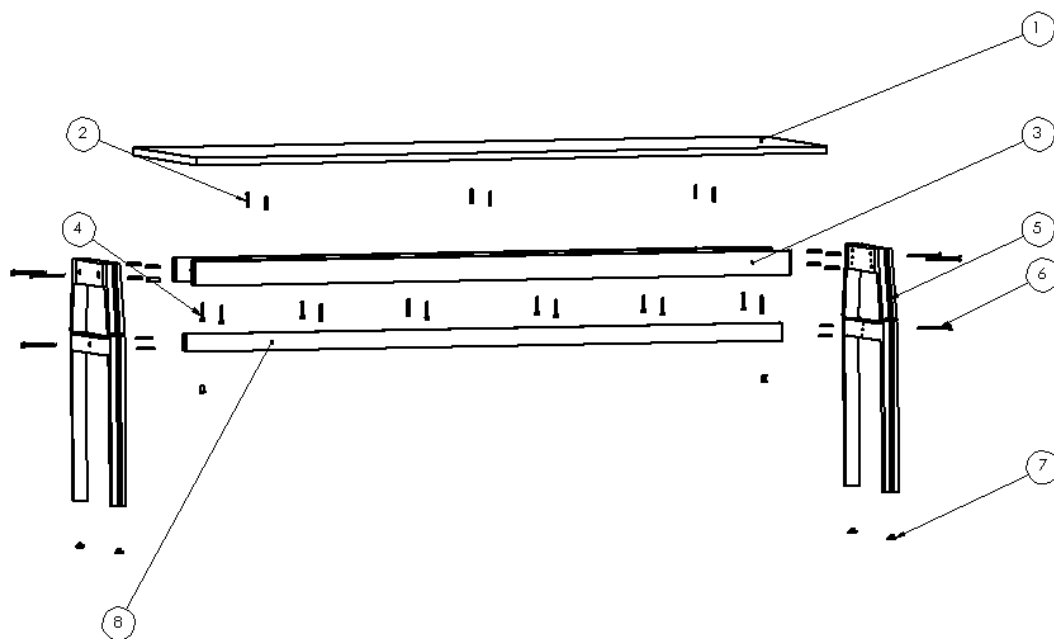
